Please find enclosed information regarding opportunities for those wishing to participate in the **Miami County Poultry Queen/King and Princess/Prince contest**. Please forward this letter and enclosed application to **any** interested members (a club nomination is **not** necessary).

Eligibility requirements are as follows:

- Queen/King contestants are between the ages of 14-18 (as of Jan 1), and Princess/Prince Contestants are between the ages of 8-13 (as of Jan 1).
- In good standing with their 4-H Club; Advisor signature required.
- Must be exhibiting Poultry in the 2024 Miami County Fair.
- Complete (in ink) enclosed application
- Each contestant is required to complete a poster related to poultry. The topic and contents can be of their choice. The poster will be on display during the fair in the poultry barn. Please bring the completed poster at the time of the interview.
- The completed application is to be received by April 6, 2024, for Queen/King and Princess/Prince applicants.
- **NO late applications will be accepted.**

Expectations of the winners include assisting at Poultry shows and other suggested fair events. While representing their species during the fair, the Queen/King and Princess/Prince should abide by the showman rules, including attire. The representatives are encouraged to participate in various parades, but need to make their own arrangements to do so.

The contest for **Poultry Queen/King and Princess/Prince** will be held on April 13, 2024 at Fricker's of Troy. Contestants will be contacted with an interview time and are asked to wear business attire to their interview.

 - c. Other fairs, including The Ohio State Fair, and parades during the year of reign.

Disqualifications:

1. Marriage and/or pregnancy will constitute an automatic resignation.
2. Anyone who cannot fulfill their obligation because of acceptance of another fair title, ill health, moving or other valid reason will be required to relinquish their title.
3. Anyone who is found guilty of criminal wrong doings or immoral/licit behavior during their reign will be removed from the court and any awards will be returned.

Upon resignation of the reigning Queen/King, the first attendant will be crowned. If she/he cannot fulfill her/his obligation for any reason, the title and properties will be given to the second attendant, and so forth.
